Once your application is submitted through this site, Heritage will receive an email of your submission as well as any updates on the status of your application. <u>Please follow through promptly with any instructions CFA may send you, as we do not process any</u> <u>applications until we receive a "completion status" on your account.</u> When your application is complete, a confidential finance meeting will take place to discuss potential assistance awards for our families and you will be notified shortly thereafter. This process takes a bit of time, so the sooner you apply, the sooner you will know if you qualify for assistance. **Returning families are encouraged to complete the application process by July 1, 2017.** Assistance results are usually determined by mid-August.
